O R D E R 12.6.18

The petitioner Sri B.L. Kejriwal as well as the public authority to be represented by the SPIO of the office of the Deputy Commissioner, Dibrugarh – both are absent without any information.

From perusal of the case records it is seen that the petitioner filed an RTI petition dated 14.9.17 before the Deputy Commissioner, Dibrugarh seeking copy of all applications by all parties, order sheets, Indemnity Bond, etc. since 24.5.2017 in land acquisition case no. DRA.62/15 at his own cost. From perusal of the second appeal petition it appears that the petitioner was furnished only a copy of order dated 28.8.17 vide Addl. Deputy Commissioner, Dibrugarh's letter dated 7.11.17. No other informations were furnished to him. The case records also reveal that the petitioner filed his first appeal petition dated 16.11.17 before the first appellate authority of the office of the Deputy Commissioner, Dibrugarh. Not getting any response on his first appeal petition within the stipulated time, the petitioner has approached this Commission with his second appeal petition dated 19.01.18.

In the absence of both the parties at the time of hearing today, it could not be ascertained whether remaining informations have meanwhile been furnished and received by the concerned SPIO and the petitioner respectively. It appears that the first appellate authority did not hear the first appeal petition dated 16.11.17.

In view of the above, the SPIO of the office of the Deputy Commissioner, Dibrugarh is directed to furnish the sought for informations, which are admissible under the RTI Act, 2005, to the petitioner at his own cost, within 15 days from the date of this order, if the same have not already been furnished in the mean time.

With the above order, the second appeal petition dated 19.1.2018 is disposed of.
