O R D E R 05.07.2018

- 1. The petitioner Sri Utpal Das is present. The public authority is represented by Sri Naren Ch. Basumatary, Joint Secretary and SPIO of Home & Political Department.
- 2. The second appeal petition dated 26-3-2018 is taken up for hearing with reference to the petitioner's RTI petition dated 03-10-2017, in presence of both the parties.
- 3. From perusal of the case records it is seen that the petitioner filed an RTI petition dated 3-10-2017 before the SPIO of the office of Chief Minister's Secretariat, Assam. In his RTI petition he sought informations on more than one matter relating to a complaint petition filed by him before the Commissioner of Police, Guwahati city on cable T.V. operators as well as service matters of Police personnel of different categories.
- 4. The SPIO of Home and Political Department submitted a written statement stating that the RTI petition was not received in the Department from C.M's Secretariat. By a letter dated 17-2-2018 the petitioner was informed about this and was requested to furnish a fresh RTI application. It appears that the petitioner has not furnished the same to the SPIO of Home & Political Department.
- 5. Therefore, the position as it stands today is that his RTI petition dated 03-10-2017 remains un-responded to.

- 6. In view of the above, the petitioner is directed to submit a fresh copy of the RTI petition to the SPIO of Home & Political Department for taking further necessary action from their end.
- 7. With the above order the second appeal petition dated 26-3-2018 is disposed of.
