ORDER 13.07.2018

- 1. The petitioner Sri Debajit Goswami is present. The public authority, i.e., the Directorate of Agriculture, Govt. of Assam is represented by :- (i) Sri Dayal Ch. Kro, Joint Director and SPIO of the Directorate of Agriculture, Khanapara, Guwahati-22 (ii)Smti Parijat Kanan Baishy, ADO, of the office of Directorate of Agriculture, (ii) Sri Puranjoy Goswami, Executive Engineer (Agriculture), of the Directorate of Agriculture, and (iii) Sri Satyajit Borgohain, Asstt. Agriculture Engineer, of the office of Director of Agriculture, Assam, Khanapara, Guwahati-22.
- 2. The second appeal petition dated 3-5-2018 is taken up for hearing in presence of both the parties.
- The SPIO of the Directorate of Agriculture has submitted a written statement dated 12-7-2018 together with supporting documents, which is entered into the case records. It is seen that the RTI petition dated 8-3-2018 was transferred by the SPIO, Agriculture Department to the Chief Engineer of the Directorate of Agriculture vide letter dated 16-3-2018. Thereafter by a letter dated 2-4-2018 the Chief Engineer furnished pointwise reply to the petitioner Sri Debajit Goswami. The Chief Engineer also informed the petitioner that he can inspect the relevant files in presence of officers and staff during office hours. In course of today's' hearing it transpired that the petitioner did not receive the letter.
- 4. The SPIO of the Directorate of Agriculture is, therefore, directed to facilitate inspection of records available in the office of the Chief Engineer of the Directorate of Agriculture by the petitioner on any working day during office hours within 15 days from the date of this order, which was pronounced in presence of both the parties.

5. With the above order the second appeal petition dated 3-5-2018 is disposed of with the provision that the petitioner will be at liberty to revert to this Commission if he is not satisfied with the informations so furnished.
