O R D E R

1. The petitioner Sri Kamal Rajbongshi is present. The public authority is represented by Md. Saifun Noor Ahmed, DGM (Law) and SPIO of the office of the Managing Director, APDCL, Bijulee Bhawan, Guwahati-1 and Sri Deism Hazarika, DM (IT), R- APDRP, APDCL, Bijulee Bhawan. The second appeal petition dated 9.4.18 is taken up for hearing in presence of both the parties.
2. The DGM and SPIO of the office of the MD, APDCL has submitted a written statement dated 11.6.18, which is entered into the case records.
3. From perusal of the case records it is seen that the petitioner filed an RTI petition dated 17.01.18 before the SPIO of Assam power Distribution Company Ltd. The petitioner was a candidate for the post of Assistant Manager in the Electrical, Mechanical, Civil, Instrumentation, IT and HR wings of APDC L/AEGCL and APGCL. Vide his RTI application, the applicant sought informations about marks scored by the candidates who were called for the interview along with other informations as mentioned in the RTI application. After going through the content of the RTI petition it appears that the sought for informations are admissible under the RTI Act, 2005. It also transpired in course of today's hearing that the APDCL conducted the recruitment tests, both written and oral for AEGCL and APGCL also. Therefore, the SPIO of APDCL is directed to furnish the sought for informations to the petitioner within 15 days from the date of this order, which was pronounced in presence of both the parties.

With the above order, the second appeal petition dated 9.4.18 is disposed of.
