ORDER 10.07.2018

- 1. The petitioner Sri Utpal Das is present. The public authority i.e., Guwahati Municipal Corporation (GMC) are represented by :- (i) Smti Alin Begum, APIO, Planning Branch, GMC, (ii) Smti Loni Barpatra Gohain, Collector, GMC, B.O Market, (iii) Sri Jogesh Gogoi, Superintendent (M), GMC, and Sri Mumtaj Hussain, UDA (Market).
- 2. The Second appeal petition dated 26-3-2018 read with the petitioner's RTI petition dated 14-11-2017 is taken up for hearing in presence of both the parties.
- 3. From records it is seen that the petitioner filed an RTI petition dated 14-11-2017 seeking five (5) different informations from GMC.
- 4. The SPIO of GMC has submitted a written statement dated 9-7-2018 stating that the informations regarding point No.-1 has since been furnished to the petitioner.
- 5. As regards point Nos.2, 3 and 4 of the RTI petition, it was stated that the sought for informations related to different branches of GMC and, therefore, sought 15 days' more time to furnish the reply.
- 6. As regards, point No.-5 the SPIO submitted a separate written statement dated 10-7-2018 stating that GMC has no whole sale fish market at Gorchuk. Therefore, no NOC could be furnished in this regard. Further, she mentioned that they have a whole sale fish market at Betkuchi.

- 7. In view of the above, the SPIO of GMC is directed to allow the petitioner to inspect the relevant records in respect of point No.2, 3 & 4 of his RTI petition after 15 days and within 30 days of this order and take notes and photocopies of documents that he may require, free of cost up to 50 pages and thereafter at the rate of Rs. 2/- for every additional page of photocopy.
- 8. With the above order the second appeal petition dated 26-3-2018 is disposed of.
