ORDER 18.07.2018

- 1. The petitioner Sri Dulal Broa is present. The public authority is represented by Sri Naren Ch. Basumatary, Joint Secretary and SPIO of Home & Political Department, Dispur, Guwahati-6.
- 2. The second appeal petition dated 27-6-2017 is taken up for further consideration in pursuance of this Commission's earlier orders dated 25-5-2018, and 20-6-2018.
- 3. The SPIO and Joint Secretary of Home and Political Department has submitted a written statement dated 18-7-2018 detailing the actions taken by the Department for furnishing the required information.
- 4. Earlier on 21-6-2018 also the SPIO and Joint Secretary, Home and Political Department submitted a separate written statement enclosing the same documents which have been attached to his W/S dated 18-7-2018.
- 5. It may be mentioned that an inquiry report dated 14-3-2015 was received from the Deputy Commissioner of Police, (Crime), East Police District regarding Hatigaon police station case No. 285/2014 U/S 302 IPC relating to the unnatural death of Late Manikut Pathak, ACS.
- 6. The petitioner submitted orally that he received AIGP's letter dated 04-4-2018, but without a copy of the inquiry report dated 14-3-2015 submitted by the Deputy Commissioner of Police, East Police District.
- 7. The SPIO of Home and Political Department, submitted that he has no objection to furnishing of a copy of the said inquiry report to the petitioner Sri Dulal Bora.

He is, therefore, directed to furnish a copy of the DCP, East Police District, Guwahati's report dated 14-3-2015 to the petitioner within 7 (seven) days from the date of this order, which was pronounced in presence of both the parties.

8. With the above order the second appeal petition dated 27-6-2017 is disposed of.
