ORDER 16.8.18

The petitioner Md. Abdul Jalil Akhanda is present. The public authority is represented by Shri Kamal Medhi, Executive Engineer (PHE) Nagaon Division. The second appeal petition dated 27.4.2018 is taken up for hearing in presence of both the parties.

From perusal of the case records it is seen that the petitioner filed an RTI petition dated 16.2.18 before the Executive Engineer (PHE), Nagaon Division seeking three sets of information relating to revival of defunct schemes year-wise for the financial year 2014-15, 2015-16 and 2016-17. The Executive Engineer (PHE) Nagaon Division has submitted a written statement dated 8.8.2018 enclosing a copy of letter dated 14.3.2018 addressed to the petitioner Md. Abdul Jalil Akanda furnishing the sought for informations. The Executive Engineer, PHE submitted orally that the above correspondence was sent to the petitioner by post. The petitioner has submitted that he did not receive the above communication dated 14.3.2018 from the Executive Engineer (PHE), Nagan Division.

In view of the above, the Executive Engineer PHE), Nagaon Division is directed to hand over the informations already furnished to the petitioner once again, today positively, and receive an acknowledgment for the same. After going through the informations so received, if the petitioner is not satisfied then he may request the Executive Engineer (PHE), Nagaon Division for inspection of records by giving at least two days' advance notice. The Executive Engineer (PHE) Nagaon Division is also directed to allow the petition to inspect the relevant records during office hours on any working day, within 15 days from the date of this order, which was pronounced in presence of both the parties and allow the petitioner to take notes and photocopies of required documents free of cost upto 20 pages and thereafter on payment of Rs.2.00 for every additional page of photocopy.

With the above, the second appeal petition dated 27.4.2018 is disposed of.
