**O R D E R**

The petitioner Smti. Kalpana Bala Das is present accompanied by her brother Shri Ganga Charan Das. The public authority is represented by Lot Mandal, Shri Akhil Kumar Ray. The second appeal petition dated 26.4.2018 is taken up for hearing in presence of both the parties.

From perusal of the case records it is seen that the petitioner filed an RTI petition dated 7.12.2017 before the SPIO of the office of the Deputy Commissioner, Bongaigaon seeking three sets of information relating to dag no. 180, 182 and 184 of village Nagarjhar, Ward no.5, Mouza Bijni, Revenue Circle, Bijni, Dist. Bongaigaon. From the case records it appears that the Circle Officer, Bijni Revenue Circle had already furnished the sought for informations to the petitioner vide letter No. DC-4/RTI-2018/5 dated 17.2.2018 except the copies of relevant Chitha, Jamabandi and mutation. The petitioner submitted that she will be satisfied if she is given the documents mentioned in her RTI petition dated 7.12.2017. The representative of Deputy Commissioner, Bongaigaon submitted that he has with him all the original records. This Commission, therefore, directed him to furnish copies of the same to the petitioner today and receive an undertaking from the petitioner in acknowledgment of receipt thereof.

With the above order, the second appeal petition dated 26.4.2018 is disposed of.
