The petitioner Shri N.I. Mazarbhuiyan is absent without any information. The public authority, i.e. Water Resources Department is represented by:- (1) Shri Pitambar Deka Boro, Asstt. Chief Engineer and SPIO, Water Resources Department Govt. of Assam, (2) Shri Abon Eusuf Md. K. Zaman, Asstt. Executive Engineer, Hailakandi Investigation (Water Resources) Sub-Division and (3) Md. Mustaquim, Asstt. Engineer of the office of the Chief Engineer, Water Resources Department, Chandmari. The second appeal petition dated 23.3.2018 is taken up for hearing ex-parte in the absence of the petitioner.

(a) The Executive Engineer, Cachar Inv. (WR) Division, Badarpur, (b) SPIO cum Asstt. Chief Engineer, Water Resources Department, Chandmari and (c) The first appellate authority cum Chief Engineer, Water Resources Department, Govt. of Assam have sent three separate written statements dated 9.8.2018, 9.8.2018 and 2.8.2018 respectively.
