## ORDER 13.09.2018

Sri Hemanga Das, ADO, Rampur as deputed by the Sub-Divisional Agriculture Officer, Barkhetri Bartala is present. He submitted a Written Statement dated 13.09.2018.

Perused the Written Statement and its enclosure and heard the ADO. It was submitted that the information has been furnished after receiving the Commission's notice for hearing.
