## <u>O R D E R</u> 10.09.2018

Sri Ajit Kumar Das, Assistant Executive Engineer/SPIO, PWD Mukalmua Rural Road Sub-Division is present along with Sri Upagupta Maral, Assistant Executive Engineer, PWD Nalbari Rural Road Division, Nalbari.

A Written Statement dated 05.09.2018 received from the First Appellate Authority/ Executive Engineer, PWD Nalbari Rural Road Division, Nalbari.

The Appellant absent. He informed by phone that he was unable to find public transport to travel to the Commission to attend the hearing owing to disruption in the public transport system.

Perused the case record. The Appellant had submitted his Second Appeal dated 30.07.2018 stating that only part of the information he had sought through his RTI Application dated 30.05.2018 had been furnished to him. It is seen that the Appellant had sought information on 'Completion' and 'Fitness' certificate relating to two roads constructed by the PWD Rural Road Sub-Division.

Perused the Written Statement and heard the SPIO and the deputee of the FAA. Detailing the action taken on the RTI Application and the First Appeal dated 30.06.2018, the Respondents submitted that the information on record was provided promptly through a letter dated 13.06.2018 which was within 8 days of receiving the Application. Another letter was issued to the Appellant on 10.07.2018 covering both the points of the Application and explaining that the Department did not issue so called "Fitness Certificate" in respect of any work but "Completion Certificate".

Considering that the SPIO has furnished the information as available on record, the Second Appeal is herby disposed of.
