**O R D E R**  
**10.10.18**

1. The petitioner Sri Dulal Bora is present. The public authority is represented by Shri Niranjan Bora, Under Secretary and SPIO of Chief Minister's Office (CMO) accompanied by Sr. AA, Shri Prabal Jyoti Medhi. The second appeal petition dated 3.7.2017 is taken up for hearing in presence of both the parties.

2. From perusal of the case records it is seen that the petitioner filed a complaint petition dated 21.6.2016 before the Hon'ble Chief Minister of Assam requesting him to take necessary action against one Smti. Mamota Hojai, who was allegedly involved in some murder case.

3. Subsequently vide an RTI petition dated 13.8.2016 sought the following informations from the SPIO of the CMO:-

(a) *The number of the file from which inquiry was ordered into the allegations mentioned in his complaint petition dated 21-6-2016, and name of the Inquiry Officer with his designation.*

(b) *Names and address of the persons mentioned in the complaint petition dated 21-6-2016 and*

(c) *Photo copy of inquiry report submitted by the Inquiry Officer to his higher authorities.*

4. Since the names of the officers alleged against are already mentioned in the complaint petition dated 21-6-2016, at point No. 3(b) above is considered to be redundant

5. Not getting any information the petitioner filed his first and second appeal petitions on 22.5.2017 and 3.7.2017 respectively.

6. The Under Secretary and SPIO of CMO has submitted a written statement dated 10.10.2018 stating that the petitioner's original complaint petition vide letter No. DB.659/4/16 dated 21.6.2016 was forwarded to the Secretary to the Govt. of Assam, Education (Secondary) Department vide CMO Diary No. 6088 dated 24.6.2016. Subsequently the RTI petition was also transferred to the SPIO of Secondary Education, Govt. of Assam vide CMO Diary No. CMS.7/2016(RTI/Pt.IV/645 dated 16.5.2018. It transpired in course of hearing that Smti. Mamota Hojai is presently working as Joint director of Secondary Education, Govt. of Assam. It also transpired that

the petitioner has not received any information in response to his RTI petition and subsequent first appeal petition from the Secondary Education Department.

7. The SPIO of Secondary Education Department is directed to furnish the sought for informations in respect of paragraph No. (a) and (c) of petitioners RTI petition dated 13.8.2016 within 15 days from the date of receipt of this order.
