**O R D E R**  
**05-10-2018**

1. The petitioner Sri Narendra Prakash Chouhan is present. The public authority is represented by Sri Babul Ch. Das, Deputy Conservator of Forest, Office of the Conservator of Forest, North Assam Circle, Tezpur and Sri Nagendra Nath Deka, Deputy Conservator of Forest, Eastern Assam Circle, Jorhat.
2. The second appeal petition dated 9-1-2018 read with the RTI petition dated 17-7-2017 is taken up for hearing in presence of both the parties. Both the DCFs present submitted orally that they have meanwhile furnished the informations available with them to the petitioner in respect of 22 divisions. They have also mentioned orally that the sought for informations are held by the concerned Divisional Forest Officers. The petitioner also agreed receipt of informations against 22 divisions. He submitted that he is yet to receive informations regarding 11 Divisions.
3. As mentioned above, since the sought for informations are held by the concerned Divisional Forest Officers of the respective divisions, the SPIO of the office of Principal Chief Conservator of Forest is directed to transfer, within 7 days from receipt of this order, the RTI petition under Section 6(3) of the RTI Act, 2005 to the DCFs of the remaining 11 forest divisions with the instruction to furnish the related information within 30 days from the date of receipt of the transferred RTI petition.
4. With the above order the second appeal petition dated 9-1-2018 is disposed of.
