ORDER

06-11-2017

The petitioner Shri Akhtar Hussain Laskar present stated that he approached the office of the C.E.O. Zilla Parishad on 16-10-2017 to allow him to inspect the records on 18-10-2017 as instructed by the Commission vide order dt. 13-10-2017. He submitted a copy of the receipt given by the office of the C.E.O., Zilla Parishad on 16-10-2017. He stated that since 18-10-2017 was holiday, he did not visit the office. He also stated that he had requested the C.E.O., Zilla Parishad to allow him to inspect the documents on 20-10-2017 which was also received by the office of the C.E.O., Zilla Parishad, but he was not permitted to inspect the documents. He also stated that the C.E.O., Zilla Parishad was not available in the office. The petitioner requested in the Commission to direct the C.E.O., Zilla Parishad to fix a date for inspection of document and intimate the petitioner.

In view of the prayer of the petitioner, the C.E.O. Zilla Parishad is directed to fix a date for inspection of document by the petitioner within 21 days from the date of receipt of this order and inform the petitioner at least three days before the date fixed for inspection with intimation to this Commission and allow him to take notes and photocopies of the sought for documents free of cost up to 20 copies and thereafter on payment of Rs.2/- for every additional page of photocopy.
