ORDER
11-10-2017

The petitioner Shri Sumen Roy is absent without any intimation. The Public Authority is represented by Shri Subhash Ch. Sarkar is F.I. for District Social Welfare Officer. The District Officer is cautioned to be present personally for hearing.

The District Social Welfare Officer had submitted a written statement dt. 7th October, 2017 that for information of 1st part of point No.1, three letters were issued to the Hon'ble Chief Judicial Magistrate on 17-2-2017, 15-3-2017 & 21-6-2017 to provide the list of the Domestic Violence Cases with copy to the petitioner. The information for rest part of point No.I, II, part of VII & VIII had already been provided to the petitioner vide his letter dt. 15-3-2017. The Public Authority present stated that petition for the Domestic Violence Cases were submitted to the Addl. Chief Judicial Magistrate and Chief Judicial Magistrate. For field report of incidents, some cases were referred to the Social Welfare Officer. Since information on list of Domestic Violence Cases are reported to be maintained by the Addl. Chief Judicial Magistrate, Karimganj the matter be transferred to the SPIO, Office of the Chief Judicial Magistrate under Sec.6(3) of the R.T.I. Act,2005. He has also stated that for providing information against Point No. III - VII, the petition was transferred to 7 No. of C.D.P.O. under Karimganj District under Sec. 6(3) of the R.T.I. Act, 2005 with the request to provide the information directly to the petitioner with information to them.

The Public Authority present stated that out of 7 no. of C.D.P.Os, six posts were vacant and one C.D.P.O. who was posted was also holding the charge of the District Social Welfare Officer, Karimganj. He also stated that the Circle Officer and B.D.Os. of the area were engaged by the District Administration in performing the duties of C.D.P.Os and were not under the control of the D.S.W.O.

The Commission therefore, directs the C.D.P.Os under Karimganj District to furnish the information to the petitioner.
