**O R D E R**  
26.10.2018

1. The petitioner Shri Dulal Bora is absent. However, he has sent an e-mail dated 26.10.2018 praying for re-fixation of the date of hearing as he is out of station in connection with a court case in Dibrugarh. The public authority, i.e. Personnel Department is represented by Shri Prasanta Borkakati, ACS, Deputy Secretary and SPIO of Personnel & ART Department, Govt. of Assam accompanied by Sr. AA, Shri Ankur Sarma.

The SPIO and Deputy Secretary, Personnel Department submitted orally that there is no record in the Department of having received petitioner Shri Dulal Bora's RTI petition vide D.No.DB-1722/16 dated 17.12.2016. From perusal of the case records it is seen that the petitioner's RTI petition mentioned above is with reference to a complaint petition dated 3.7.2015 addressed to the Addl. Chief Secretary of Personnel Department containing allegations against one Md. Mehtab Ali, District Transport Officer. It appears to the Commission from perusal of the relevant case records that the subject matter of instant second appeal case relates to Transport Department. The SPIO of personnel Department is, therefore, directed to collect a copy of the RTI petition, original complaint petition dated 3.7.2015 and other relevant papers from the Registry of this Commission today and thereafter transfer the RTI petition to the SPIO of Transport Department within 5 days. The SPIO of Transport Department is also hereby directed to furnish the sought for informations to the petitioner within 30 days from the date of receipt of the transferred RTI petition from the Personnel Department

With the above orders, the second appeal petition dated 14.8.2017 is disposed of
