**O R D E R**

The Appellant Shri Jalal Uddin Laskar is present.

The Block Development Officer, Salchapara Development Block has made a written submission to exonerate him from attending the hearing today due to some urgent official work. He requested to fix another date of hearing.

On perusal of records, it appears that the petitioner sought for information relating to all schemes of road upgradation/repair that were undertaken by the Rajnagar G.P. w.e.f. 13<sup>th</sup> June till date, alongwith detailed plan and estimate etc. for the road connecting Ganigram Bazar ferryghat with T.R.K. Road at Nischintapur Village.

Due to non receipt of information from the SPIO Office of the B.D.O., Salchapara Development Block, Cachar on his RTI petition dt. 8-12-2016 and non receipt of any response from the 1<sup>st</sup> Appellate Authority on his first Appeal dt. 20-1-2017, he filed a complaint petition on 20-5-2017.

The Commission observes that the information sought for by the petitioner vide his R.T.I. application dt. 8-12-2016 involves a huge volume of information relating several years w.e.f. 2013 till date. Furnishing of complete information by making photocopies will require substantial expenditure.

The Commission therefore directs the petitioner to inspect the relevant office records and documents in the office of the B.D.O., Salchapara within 15 days from the date of receipt of the order and complete inspection of documents during office hours. The petitioner will give at least two days prior notice to the public authority for inspection of documents.

The B.D.O., Salchapara, Cachar is also directed to allow the petitioner to inspect the relevant records and documents and allow him to take notes and photocopies of the sought for documents free of cost upto 25 copies and thereafter on payment of Rs.2.00 for every additional page of photocopy.
