**O R D E R**  
15.09.2017

Non Compliance petitions filed by Shri Jiyaaur Rahman dt. 6/6/2017 and 17/7/2017 of Commissions order dt. 24-2-2017 by the Deputy Commissioner, Cachar is taken up for consideration. He stated that the Addl. Deputy Commissioner i/c RTI vide letter dt. 4-5-2017, directed C.E.O., Zilla Parishad, Silchar, to dispose the matter within 10 days, being the first Appellate Authority of the Block Development Office of the District. Till date he has not received any satisfactory reply either from the B.D.O., Kalain Development Block, the C.E.O., Zilla Parishad, Silchar or from the Deputy Commissioner, Cachar. As such he has requested the Commission to look into the matter and pass necessary orders u/s. 19(8) (b) and Sec.20 of the RTI, 2005.

On careful perusal of the RTI petition dt. 1-2-2016, it appears that the information sought for by the petitioner should be available in the office of the B.D.O., Kalain Development Block. The Commission therefore, directs the SPIO in the office of the B.D.O., Kalain Development Block, as well as the first Appellate Authority i.e. C.E.O. Zilla Parishad, Silchar himself to make available the relevant record for inspection by the petitioner personally within 15 days from the date of receipt of this order. The petitioner should also be given copies of documents that he wants in response to his RTI petition, after depositing the cost thereof, as estimated by the SPIO of the B.D.O., Kalain Development Block.

Under section 18(3) of the RTI Act, 2005, the B.D.O. Kalain Development Block and the SPIO in his office, are hereby directed to show cause, as to why further action under section 18, 19 and 20 of the RTI Act, 2005 shall not be taken up against them for their failure to perform the responsibilities under the Act. Their written submission should reach this Commission within 15 days from the date of receipt of this order.
