O R D E R
30.10.2018

1. The petitioner Shri Rajib Deka is present. The public authority, i.e. Assam Seeds Corporation Ltd, Goalpara Branch is represented by: - (1) Shri Manoranjan Goswami and (2) Shri Dipak Das, ex-Branch Manager and Present Branch Manager respectively. The non-compliance complaint petition dated 17.10.2017 and complaint petition dated 4.7.2018 are taken up for hearing in presence of both the parties with reference to this Commission's earlier order dated 30.8.2017,
2. The petitioner submitted orally that he contacted the ex-Branch Manager, Shri Manoranjan Goswami, but due to his other preoccupations inspection of records did not take place. Meanwhile Shri Dipak Das has taken over as i/c Branch Manager of ASCL, Goalpara Branch after Shri Manoranjan Goswami has been transferred to Sivasagar Branch. The present i/c Branch Manager submitted orally that he will furnish all available informations to the petitioner when he comes for inspection of records. He, however, mentioned that except for telephone numbers of some resource persons, other sought for informations are in office.
3. The petitioner is, therefore, directed to visit the office of the Assam Seeds Corporation Ltd. Goalpara Branch, by giving two days' advance notice, for inspection of the relevant records during office hours on any working day within 15 days from the date of this order, which was pronounced in presence of both the parties. The i/c Branch Manager of ASCL, Goalpara Branch is also directed to allow the petitioner to inspect all relevant records with reference to the RTI petition dated 18.5.2017 as above within 15 days from today and allow him to take notes and photocopies of required and admissible records free of cost upto 50 pages and thereafter on payment of Rs.2.00 for every additional page of photocopy. If necessary the Branch manager, ASCL, Goalpara will attach the documents with his seal and signature.

With the above order, the second appeal petition dated 14.7.2017 and the complaint petition mentioned above are disposed of.
