1. The petitioner Shri P.K. Sarmah is present accompanied by Dr. A. Goswami and Shri J.N. Borah. The public authority, i.e. Guwahati Municipal Corporation is represented by :- (1) Shri Deepak Talukdar and (2) Shri Dinesh Das – both Zonal Engineers of GMC. The second appeal petition dated 18.1.2018 and complaint petition dated 27.8.2018 are taken up for hearing in presence of both the parties.

2. From perusal of the case records it is seen that the appellant by his RTI petition dated 29.7.2017 sought five different informations relating to Bhikamji Crystals Apartment situated at Tripura Road, Joyanagar, Guwahati. All the five informations sought for by the appellant are admissible under the RTI Act, 2005. The representatives of GMC submitted orally that since the name of builder was not mentioned in the RTI petition they could not furnish the informations till date. However, after consultation with the appellant it has come to know that one Shri S.S. Agarwal was the builder of Bhikamji Crystal Apartment. The Zonal Engineer of the GMC assured that he will be able to furnish all the sought for informations. The SPIO of GMC is therefore directed to furnish the same to the petitioner within 7 days from the date of this order, which was pronounced in presence of both the parties.

With the above, the second appeal petition dated 18.1.2018 is disposed of.
