

- The petitioner Sri Dulal Bora is absent. However, he has sent an e-mail dated 12<sup>th</sup> September, 2018 praying for re-fixation of the date of hearing due to his preoccupation with some other Court cases. The public authority is represented by Sri Guna Ram Engty, ASPIO and Under Secretary of Environment and Forest Department, Govt. of Assam.
- 2. The SPIO of the office of Chief Secretary, Govt. of Assam has sent a written submission dated 17<sup>th</sup> August, 2018 stating that the RTI petition dated 9-8-2016 of the petitioner Sri Dulal Bora was transferred to the SPIO of Environment and Forest Department, Govt. of Assam. Her W/S is entered into the case records.
- 3. The SPIO and Joint Secretary of Environment and Forest Department also sent a written statement dated 5<sup>th</sup> September, 2018. The W/S is entered into the case records. It has been mentioned in the W/S that the petitioner's RTI petition dated 9-8-2016 was responded to vide Environment and Forest Department's letter dated 6-4-2018, copy of which has been enclosed with the W/S. It has also been mentioned that the same RTI petition and the present second appeal petition were already disposed of by the State Information Commissioner, Smti N.A.Hazarika, vide her order dated 10-4-2018, wherein it is mentioned that the petitioner had made a written submission to the effect that he had since received the informations sought for by him vide his RTI petition dated 9-8-2016. Copy of the SIC's order dated 10-4-2018 has also been enclosed with the W/S.
- **4.** From perusal of the case records and the written submission it appears that the instant second appeal case is a duplication of an identical second appeal petition already heard and disposed of by Assam Information Commission as mentioned above.
- **5.** In view of the above, the instant second appeal petition is dismissed and the matter is treated as finally disposed of.
