1. The petitioner Sri Dulal Bora is present. The public authority to be represented by the SPIO of PW (Roads) Department is absent. The SPIO of the office of Chief Secretary is also absent..
2. The SPIO of the office of Chief Secretary has sent a written statement dated 21-8-2018 stating that the petitioner's RTI petition dated 30-7-2016 as well as the first appeal petition dated 16-5-2017 were transferred to the P.W (Roads) Department. Her written statement is entered into the case records.
3. The Under Secretary of P.W (Roads) Department has also sent a separate written statement dated 13th September, 2018 stating that the informations sought for by the petitioner was already sent vide letter dated 1-3-2016 on another similar RTI filed by him. Their point-wise reply to RTI petition dated 30-7-2016 was again furnished to the petitioner vide letter No. RBEB. 226/2018/8 dated 24-8-2018, copy of which has been enclosed with the W/S. His W/S is entered into the case records.
4. The petitioner submitted that according to his records he did not receive the above informations. The Registry of this Commission is, therefore, directed to hand over copies of the above communications received from PW (Roads) Department to the petitioner.
5. With the above order the second appeal petition dated 24-7-2017 is disposed of.
