The second appeal petition dated 14.8.2017 is taken up for further consideration in pursuance of this Commission's order dated 27.8.2018. The SPIO and the Deputy Secretary, Personnel Deptt. has submitted a written statement dated 27.11.2018 stating that the petitioner's RTI petition No.1717/16 dated 17.12.2016 relating to the allegation against one Smt. Plabita Bordoloi, Labour Inspector was forwarded to the Director of Vigilance and Anti-corruption, Govt. of Assam vide letter dated 11 October, 2018 followed by subsequent reminders. The same matter has also been forwarded to the Secretary, APSC in compliance to this Commission's order dated 27.8.2018. It is also stated that no enquiry has been initiated by the Personnel (A) Department. The copies of the above mentioned communications were annexed with the written statement. The petitioner was also informed about the above actions taken by the Personnel Department. The petitioner has also made a written statement stating that he has received the above information and submitted orally that since the Director of Vigilance is investigating into the allegation made by him he is satisfied with the actions taken by the Personnel Deptt.

In view of the above the second appeal petition dated 14.8.2017 is disposed of.
