Md. Kamrul Hussain, SPIO/Secretary, Mowamari Samabai Samiti Ltd. is present. A Written Statement submitted by the SPIO with today's date.

The Appellant absent without information.

A Written Statement dated 26.11.2018 has been received from the Addl. Deputy Commissioner and PIO, DC's office, Ngaon to whom the First Appeal dated 27.01.2015 had been submitted. It has been submitted that the Appeal could not be traced and there was no record of any action having been taken.

Heard the SPIO and perused the Written Statement. It was submitted that as the RTI Application was more than four years old he could not trace it out in the office and that on checking with the Appellant by phone he was told that he had expected the information from his predecessor.

Considering the submission by the SPIO/Secretary, Mowamari Samabai Samiti Ltd, the Commission hereby orders that he shall make best endeavour to find the information and provide the same as sought for by the Appellant, free of cost, within 15 days of receiving this order.
