O R D E R

Smt. Kalpana Saikia, Asstt. Research Officer/SPIO, office of the Directorate of Medical Education, Assam is present along with Sri Rajib Barman, LDA/Computer Operator and Sri Prakash Rajbongshi, Computer Operator, office of the Assam Council of Medical Registration. She submitted a Written Statement dated 09.11.2018.

The Appellant, Md. Ikbal Rafique is present. He submitted that he has not received the information he had sought for thorough his RTI Application dated 03.07.2017.

Heard the parties. It emerged that Assam Medical Council is the appropriate Public Authority and not the Directorate of Medical Education, Assam to provide the information. The depute of the SPIO, office of the Assam Medical Council was not certain as to whether the information sought for, namely (i) certified copies of the proceedings of the investigation by the AMC into the complaints of negligence filed by Md. Ikbal Rafique on 23.06.2013 against one Dr. Ali Asgor Mondal of Dhubri Civil Hospital, Dhubri, and (ii) the copy of the order of the AMC dated 21.02.2014 where the alleged delinquent Doctors had been found to be not guilty was available in the records. It also transpires that the Appellant had provided with some documents which were not the one sought for by him.

In view of the facts brought out above, **the Commission hereby orders that the SPIO/Registrar, office of the Assam Medical Council shall furnish the information sought for by the Appellant, free of cost, within 10 days of receiving this order.**

With this, the Second Appeal is hereby disposed of.
