The petitioner Sri Sunil Sinha is absent. The BDO, Narsinghpur Dev. Block vide letter dt. 29-11-2018 had informed the Commission that he will not be able to leave his headquarter due to Panchayat Election duties and had requested to fix another date for hearing. He had also informed that the concerned Secretary of the Narsinghpur G.P. was instructed vide letter dt. 26-12-2017 to furnish all the information to the petitioner directly which was received by him on 29-12-2017.

Since the petitioner Sri Sunil Sinha is absent without any intimation, it could not be ascertained whether the information sought for by him had been furnished to him by the Secretary of the Narsinghpur G.P., Narsinghpur Dev. Block

The Commission therefore directs the BDO, Narsinghpur Dev. Block to furnish the information to the petitioner if not already furnished within 15 days from the date of receipt of this order.

With the above direction the 2nd Appeal petition dt. 25-4-2018 is disposed of.
