# <u>ORDER</u> 18-12-2018

The petitioner Sri Hemanta Kumar Mahanta has sent a mail today that he did not receive any information from the SPIO and the 1<sup>st</sup> Appellate authority, and thus he filed a complaint petition on 30-10-2018. Even after filing of the complaint petition no action had been taken by the SPIO, O/o the Inspector of Schools, Golaghat and the 1<sup>st</sup> Appellate authority, the Inspector of Schools, Golaghat. So he requested the Commission to direct the public authority to furnish the information sought for.

It is seen that the petitioner had stated that no information had been received. Whereas the public authority had stated vide letter dt. 17-12-2018 that the petitioner was informed vide letter dt. 16-8-2010 and Regd. Letter dt. 12-9-2018 to collect the document from the O/o the Inspector of Schools by paying the photocopy cost.

The Commission therefore directs the petitioner to visit the O/o the Inspector of Schools, Golaghat within 21 days from the date of receipt of this order and complete inspection of documents during office hour. The petitioner will give at least 2 days notice to the public authority for inspection of document.

The Inspector of Schools, Golaghat is also directed to allow the petitioner to take notes and photocopies free of cost up to 25 copies and thereafter on payment of Rs. 2/- for every additional page of photocopies.
