Regarding question No. 1 of the application it was informed that the Director of Health Services was the appointing authority of nursing staff and hence U/S. 6(3) of RTI Act, 2005 the application was forwarded to the SPIO, Directorate of Health Services with intimation to the applicant.

The petitioner present admitted that he had received the information except point No. 1.

The Commission therefore directs the SPIO, Directorate of Health Services to furnish the information to the petitioner within 21 days from the date of receipt of this order.
