**O R D E R****3-12-2018**

The petitioner Sri Dishu Sandai is absent. Sri S.U. Laskar, SPIO cum Range Forest Officer, Hawaithang Afftn. Range, Cachar Division had informed the Commission vide letter dt. 27-11-2018 that the information sought for by the petitioner was furnished to him vide letter dt. 4-12-2018 and the same was duly received by the petitioner. Moreover no further correspondence had been made by the petitioner.

The petitioner has sent a mail dt. 3<sup>rd</sup> December, 2018 that due to his illness he could not attend the hearing today. He also informed that the SPIO called him to his office and gave him incomplete and false information and forcefully took his signature that he had received the information. He has therefore requested to fix another date for hearing.

The petitioner in his complaint petition dt. 11-5-2018 had stated that the SPIO had rejected his request for information malafidely and had not furnished the reply, but on perusal of the reply furnished by the SPIO to the petitioner which has been enclosed, appears that the SPIO had furnished pointwise reply to his RTI petition dt. 12-12-2017.

Since the information had been furnished as per record vide letter dt. 4-1-2018 and the petitioner had not mentioned on what point he is yet to receive any reply, the complaint petition is found to be redundant and hence dismissed.
