## <u>O R D E R</u> 01-11-2018

The petitioner Sri Abhijit Pegu is absent.

The I/C, Sub-Divisional Welfare Officer, Golaghat has informed the Commission vide mail dt. 31-10-2018 that the petitioner Sri Abhijit Pegu was informed vie letter dt. 17-7-2018 that the document relating to his RTI petition dt. 10-5-2018 was kept ready in their office and he was requested to collect the same from their office by depositing an amount of Rs. 296 only as photocopy charges of the document @ Rs. 2/- per page.

The Deputy Commissioner, Golaghat vide letter dt. 15-10-2018 informed the Commission that the RTI petition of Sri Abhijit Pegu received by them was not related to the O/o the Deputy Commissioner, Golaghat and the said petition was forwarded to the President, Golaghat S.C. Development Board on 17-5-2018 with intimation to the petitioner. The applicant filed his 1<sup>st</sup> Appeal petition dt. 29-6-2018 in the O/o the Deputy Commissioner, Golaghat and the same was forwarded to the Sub-Divisional Welfare Officer, Golaghat and the President, Golaghat S.C. Development Board on 6-7-2018 and the petition was returned to the Applicant which was received by the petitioner personally from their office.

The petitioner had submitted his 2<sup>nd</sup> Appeal petition dt. 1-8-2018 requesting the Commission to direct the public authority to furnish the information to the petitioner free of cost. Since the information sought for is not voluminous, the public authority is directed to furnish the information to the petitioner free of cost within 21 days from the date of receipt of this order.

With the above direction the  $2^{nd}$  Appeal petition dt. 1-8-2018 is disposed of.
