The petitioner Sri Afzal Hussain Barbhuiyan is present. The public authority to be represented by the SPIO, Office of the District Mission Co-ordinator, SSA, Hailakandi is absent without any intimation.

The matter has been taken up today in view of complaint filed by Sri Afzal Hussain Barbhuiyan on 16<sup>th</sup> June, 2018 that the petitioner did not receive any notice of hearing dt. 11-4-2018 and that the District Dev. Commissioner and District Mission Co-ordinator had wrongly informed the Commission that the record sought for by him vide his RTI petition dt. 5-10-2016 was handed over to him on 6-4-2018 and he was satisfied. An acknowledgement was also annexed before the Commission and the Authority disposed the matter accordingly. The petitioner complained that he had not received any information nor was any information was sent to him by post.

In view of the above the complaint petition filed by the petitioner was sent to the SPIO, O/o the District Mission Co-ordinator, SSA, Dist. Hailakandi.

The District Mission Co-ordinator is neither present for neither hearing today nor has he submitted any written statement in this regard.

The Commission therefore directs the SPIO to show cause as to why penalty U/S. 20(1) of the RTI Act, 2005 should not be imposed on him for his unauthorized absence today and failure to submit a report on the complaint petition filed by the petitioner on 18-6-2018.
