**O R D E R**

1. The appellant Sri Durgeswar Das as well as the public authority to be represented by the SPIO of Juria Development Block, Nagaon – both are absent. Meanwhile, a written communication has been received from the concerned SPIO stating that the informations sought for by the petitioner vide his RTI petition dated 9.10.2017 were already furnished to him vide letter dated 8.11.2017. But it is seen from the case records that the petitioner's first appeal petition dated 14.11.2017 and second appeal petition dated 30.1.2018 are based on the ground that no information was furnished to him by the SPIO of Juria Development Block.

2. In view of the above the appellant is directed to obtain copies of the informations which the concerned SPIO claims to have furnished vide letter dated 8.11.2017 within 15 days from the date of receipt of this order. The SPIO of Juria Development Block is also directed to furnish the same to the petitioner as and when he approaches the SPIO within 15 days from the date of receipt of this order.

With the above order the second appeal petition is disposed of.
