O R D E R

24.01.2019

1. The appellant Sri Promod Kumar Baruah is present accompanied by Sri R.N. Borpujari to assist him. The public authority is represented by Sri S.K.Khodung, Additional Chief Housing Officer and SPIO of Assam State Housing Board accompanied by Sri Prafulla Kalita, Cashier. The second appeal petition dated 12.2.2018 is taken up for further consideration in pursuance of this Commission's earlier orders, the last one being dated 7.1.2019.
2. The officials of Assam State Housing Board stated that they came prepared with the original records relating to the instant second appeal petition and RTI petition dated 15.11.2017. On advice from this Commission both the parties sat together and the petitioner inspected the relevant official records. The petitioner submitted orally before this Commission that he has received a photo copy of relevant pages of the original register containing details of pending dues and payment relating to retired employees of Assam State Housing Board from 1.1.2010 upto 31.12.2018. The petitioner pointed out that the entries in the column of . CPF dues against some employees are blank. The Cashier of Assam State Housing Board Sri Prafulla Kalita made a written submission stating that wherever the CPF dues are shown as blank it means that the CPF dues of those retired employees have been fully paid up. This being the position, the Registry of this Commission is directed to give a copy of Cashier Sri Prafulla Kalita's written statement to the appellant for their necessary action.
3. As regards point No.III of the RTI petition, the SPIO of Assam State Housing Board is directed to furnish the copies of their correspondences with the State Government for payment of remaining cash component against retirement dues of their retired employees within 7 days from the date of this order which is pronounced in presence of the SPIO of Assam State Housing Board.
4. With the above order the second appeal petition dated 12.2.2018 is disposed of.
