**O R D E R**

The Assam Police Head Quarter. deputed ASI Sri Paresh Bora with a written statement dated 3.1.2019 submitted by Sri A. Kalita, IPS, AIGP(A) and SPIO. The WS is entered into the case records. It is seen from the case records that the petitioner Sri Dulal Bora filed a complaint petition dated 15.12.2014 before the Principal Secretary, Home Department, Govt. of Assam. In his complaint petition he has levelled allegation against the then Senior Superintendent of Police Sri Anand Prakash Tiwari, IPS and others alleging Sri Tiwari's involvement in illegal extortion of money from coal traders in Beltola area of Guwahati city. The petitioner Sri Dulal Bora requested for an inquiry into the matter. He followed up his complaint petition by an RTI petition dated 31.8.2016 seeking informations about the name & designation of the Inquiry Officer and the file no. from which the inquiry was ordered, name of the persons alleged against and also requested for a copy of the inquiry report. He followed up his RTI petition by first appeal petition dated 12.5.2017 and second appeal petition dated 24.7.2017. The AIGP (A) and SPIO of Assam Police headquarter has mentioned in his WS that after inquiry, the allegations made by the petitioner Sri Dulal Bora was found to be without any authenticity. Accordingly vide letter dated 21.3.2017 the petitioner Sri Dulal Bora was informed about this.

Sri Dulal Bora has also made a separate written submission dated 3.1.2019 stating that he has already received the sought for informations to his satisfaction.

In view of the above the second appeal petition dated 24.7.2017 is disposed of.
