**O R D E R**

The petitioner Sri Dulal Barua and the public authority represented by Sri Partha Pratim Saikia, APS, Deputy Superintendent of Police, Head quarter Golaghat accompanied by ASI, Sri Paresh Barua from Assam Police Head quarter are present.

The SPIO of the office of the SP, Golaghat submitted a written statement dated 27.11.2018 stating that the information sought for by the petitioner vide his RTI petition dated 9.8.2016 has already been furnished to him.

The SPIO submitted another written statement dated 19.12.2018 which is also entered into the case records. In his WS dated 19.12.2018 the SPIO mentioned that on discovery of an unidentified dead body a police case was registered on 6.7.2015, which is now under investigation. Another police case No.226/15 was registered in Dergaon Police Station in this connection. Meanwhile four police personnel of Degaon PS were transferred in connection with these police cases. It is also mentioned that the sought for informations were already furnished to the petitioner Sri Dulal Bora.

The Joint Secretary to the Govt. of Assam, Home Department has submitted a separate written statement dated 19.12.2018 giving the sequence of actions taken by them on the RTI petition. The petitioner himself has also submitted a written statement stating that he has received the sought for informations to his satisfaction and prayed for withdrawal of his second appeal petition dated 24.7.2017.

In view of the above the second appeal petition is disposed of.
