## ORDER 06.02.2019

The petitioner Shri Durgeswar Das is absent without any information. The public authority, i.e. Nagaon Municipal Board (NMB) is represented by Shri Rajesh Kr. Das, SPIO and Asstt. Executive Engineer accompanied by Shri Subrata Biswas, Head Assistant.

The SPIO of NMB has submitted a written statement stating that he had kept all the sought for informations ready. The SPIO submitted orally that the documents were sent to his residential address by special messenger, but Shri Durgeswar Das, the applicant, could not be found there as the residential building was meanwhile demolished and the neighbours could not say the present address of Shri Durgeswar Das. In other words, the applicant was not available in his given address and he was not traceable. The SPIO has also mentioned in his WS that he tried to contact the petitioner in his mobile no. 9435224396, the phone rang but the petitioner did not receive it. As a result, the ready information materials are lying with the SPIO without being handed over to the petitioner.

In view of the above, the petitioner Shri Durgeswar Das is directed to collect the sought for informations from the SPIO of NMB within 15 days from the date of receipt of this order. If he needs any further clarification, then the SPIO, NMB is directed to allow the petitioner to inspect the relevant records during office hours on any working day within 20 days from the date of receipt of this order and he may be allowed to take notes and photocopies of additional documents free of cost upto 10 pages and thereafter on payment of Rs. 2.00 for every additional page of photocopy. If the petitioner/appellant does not take any action within the time period stipulated above, then the matter will be treated as closed and the second appeal petition dated 22.2.2018 read with RTI petition dated 02.11.2017 will be treated as disposed of.
