ORDER 07.01.2019

- 1. The petitioner Shri Atowar Rahman Bhuyan is absent without any information. The public authority, i.e. the SPIO of the Directorate of Inland Water Transport, Govt. of Assam is represented by :- (1) Shri Tilok Ch. Mahanta, Deputy Director and SPIO of Inland Water Transport, Govt. of Assam, (2) Shri Moghu Teron, Sr. Assistant, IWT, Assam and (3) Shri Tridib Raj Phukan, Jr. Assistant of the said office. The second appeal petition dated 7.9.2018 read with petitioner's RTI petition dated 19.6.2018 is taken up for hearing ex-parte in the absence of the petitioner.
- 2. The Dy. Director (D) and SPIO of Inland Water Transport (IWT), Assam has submitted a written statement dated 2nd January, 2019, which is entered into the case records. It has been stated in the WS that the petitioner's RTI petition dated 19.6.2018 was received on the Directorate of IWT on 22.6.2018. It was then forwarded to the concerned Executive Engineer, IWT, Guwahati Division on 27.6.2018. The Executive Engineer vide letter dated 10.7.2018 furnished the sought for informations to the petitioner and also informed him about availability of sought for documents for which he requested the petitioner to deposit Rs. 235.00. The petitioner deposited the required amount vide demand draft no. 983476 dated 30.8.2018. Thereafter the Executive Engineer, IWT, Guwahati Division furnished the sought for informations to the petitioner.
- 3. The Director and first appellate authority also submitted a separate written statement dated 2nd January, 2019 stating that 1st September, 2018 was fixed for hearing the first appeal petition dated 6.8.2018. But the appellant was absent at the time of hearing the first appeal petition
- 4. From the above, it appears that the petitioner has received the sought for informations with documents to his satisfaction. Therefore, the second appeal petition dated 7.9.2018 is disposed of ex-parte and the matter is closed.
