**O R D E R**

21.02.2019

1. The petitioner/applicant Sri Durgeswar Das is absent without any information. The public authority, i.e., the Directorate of Elementary Education, Govt. of Assam is represented by Smt. Rumi Choudhury, SPIO and Deputy Director accompanied by Smt. Meghali Baruah, both of whom are present. The second appeal petition dated 25.5.2018 is taken up for hearing ex parte in the absence of the petitioner.
2. The SPIO and Deputy Director of Directorate of Elementary Education has submitted a written statement dated 13.2.2019 which is entered into the case records. Another WS dated 12.2.2019 was submitted by the DEE also and it was entered into the case records. It has been mentioned in the WSs that the informations sought for vide Point No.11 of the petitioner's RTI petition dated 27.2.2018 is available in the department's website "[www.deeassam.gov.in](http://www.deeassam.gov.in)" and the petitioner was informed about this vide SPIO's letter dated 21.3.2018. As regards informations sought for vide point no.7, 8.9 and 10, it has been mentioned in the WSs that the matter was transferred to Appointment (B) SIU Branch of the Directorate. On receipt of the first appeal petition dated 6.4.2018 the 1st Appellate Authority fixed 1 P.M. on 7.5.2018 for hearing and the petitioner was informed vide letter dated 2nd May, 2018. No order appears to have been passed by the 1st Appellate Authority.
3. In view of the above, if the petitioner/appellant is still desirous of getting the informations sought for by him against point no. 7, 8, 9 and 10 of his RTI petition then he is directed to exercise the option of inspection of relevant records and document as provided under Sec.2(j) of RTI Act,2005. The SPIO & Deputy Director of the Directorate of Elementary Education is therefore directed to allow the petitioner to inspect relevant records and documents during office hours on any working day within 15 days from the date of receipt of this order and allow him to take notes and photocopies of sought for records free of cost upto 20 pages and thereafter on payment of Rs.2/- for every additional page of photocopy.
4. With the above order the 2<sup>nd</sup> Appeal Petition dated 25.5.2018 is disposed of.
