**O R D E R**

20.02.2019

1. The petitioner Sri Kumudeswar Sarma accompanied by his elder brother Sri Jogeswar Sarma is present. The public authority represented by the SPIO and ADC, Kamrup (Rural) District Sri Gunajit Roy Choudhury and Sri Munindra Nath Ngaty, ADC, Land Reforms Branch of Kamrup (R) Dist. is also present.
2. The second appeal petition dated 9.7.2018 is taken up for further consideration in pursuance of this Commission's earlier order dated 18.2.2019.
3. The ADC of Land Reforms Branch of Kamrup (R) submitted orally that he has discussed the matter with the petitioner who is in possession of the relevant records pertaining to Govt. letter No. RRT.19/2009/109 dated 20.6.2014. The petitioner agreed to furnish copies of records available with him to the ADC, Land Reforms Branch for doing the needful as requested by Government in the Revenue Department vide their letter dated 20.6.2014 mentioned above. The ADC also submitted that on receipt of those records from the petitioner, he will be able to reconstruct the file and do the needful within 7(seven) days.
4. In view of the above, the petitioner as well as ADC of Land Reforms Branch of Kamrup (R) District fulfill their assurances as mentioned above and the ADC is directed to report compliance of action taken by 10<sup>th</sup> of March, 2019.
5. With the above order, the 2<sup>nd</sup> Appeal Petition dated 9.7.2018 is disposed of.
