**O R D E R**

22.02.2019

1. The petitioner/appellant Sri Himadri Dhar is present accompanied by his learned Advocate Sri Dipjyoti Chakraborty. The public authority is represented by Sri Ranjit Konwar, ACS, Addl. Deputy Commissioner and SPIO of Kamrup (M) District accompanied by Sri Damodar Barman, ACS, Circle Officer, Guwahati Revenue Circle.
2. The 2<sup>nd</sup> appeal petition dated 15.6.2018 read with the RTI petition dated 16.5.2017 filed by the petitioner is taken up for hearing in presence of both the parties. The Addl.DC and SPIO of Kamrup (M) District submitted a written statement dated 2.2.2019, which is entered into the case records. It has been stated in the WS that the RTI petition was transferred to the Circle Officer, Guwahati Revenue Circle to furnish the sought for information to the petitioner. But not getting satisfactory reply from the Circle Officer the petitioner filed the first appeal petition dated 10.8.2017 followed by the instant 2<sup>nd</sup> appeal petition dated 15.6.2018 before this Commission.
3. From perusal of the RTI petition it is seen that the petitioner wanted informations about officials and employees of Guwahati Revenue Circle involved in land mutation during the period from 1.4.2014 to 31.8.2014. In his RTI petition the petitioner also mentioned a few names of specific employees.
4. The Commission is of the view that some sought for informations, like names of employees, permanent and present address, salary details etc. are required to be published suo motu by the concerned public authority under Section 4(i)(b) of the RTI Act, 2005. Some sought for informations like Pan Card No. of employees seem to belong to the category of 3<sup>rd</sup> party informations. The Circle Officer, Guwahati Revenue Circle is therefore directed to furnish the admissible available informations to the petitioner within 15 days from the date of receipt of this order. As regards the part of sought for informations that the Circle Officer may not be able to furnish, he is directed to inform the petitioner the reasons for his inability to furnish the same.
5. With the above order the 2<sup>nd</sup> appeal petition dated 15.6.2018 is disposed of.
