<u>ORDER</u> 26.02.2019

1. The petitioner Smt. Kalpana Bala Das is present accompanied by her brother Sri Ganga Charan Das. The public authority, i.e., the SPIO of the Office of the Deputy Commissioner, Bongaigaon is absent without any information. The complaint petition dated 18.8.2018 filed by the petitioner is taken up for hearing ex parte in the absence of the SPIO.

2. It was recorded in this Commission's order dated 16.8.2018 based on the submission of the representative of the Deputy Commissioner, Bongaigaon, Lot Mandal Sri Akhil Kumar Ray that he had brought with him all the original records and therefore this Commission directed him to furnish copies of the same to the petitioner on that very day and receive an undertaking from the petitioner in acknowledgement of receipt thereof. The present complaint is that after the hearing on 16.8.2018 the Lot Mandal left this Commission's premises without furnishing the sought for documents to the petitioner in violation of his assurance and the order of this Commission. **This is viewed seriously**.

3. In view of the above, the following orders are passed :-

- (a) The petitioner is directed to contact the SPIO of the office of the Deputy Commissioner, Bongaigaon personally during office hours on any working day within 15 days from the date of receipt of this order,
- (b) The SPIO of the office of the Deputy Commissioner, Bongaigaon is directed to furnish the sought for documents as already ordered vide this Commission's vide order dated 16.8.2018 (copy enclosed for ready reference) to the petitioner and report compliance to this Commission on or before 22.4.2019.
- (c) The Deputy Commissioner, Bongaigaon is directed to cause an inquiry against Sri Akhil Kumar Ray, Lot Mandal and draw up departmental proceeding against him if he is found prima facie guilty after the inquiry of not keeping his own assurance and direction of this Commission vide order dated 16.8.2018, and report compliance.
- 4. Fix 22.4.2019 at 12.30 P.M. for review of action taken.
