## <u>O R D E R</u> 20.02.2019

The petitioner Shri Durgeswar Das is absent without any information. The public authority, i.e. the Kaliabor Development Block is represented by Shri Chandan Bordoloi E.O. (F) and SPIO accompanied by eight GP Secretaries, 2 of whom are holding dual charges. In other words, they represent the 10 GPS. The second appeal petition dated 19.2.2018 is taken up for hearing ex-parte in the absence of the petitioner.

From perusal of the case records it is seen that the petitioner filed an RTI petition dated 8.11.2017 before the SPIO of Kaliabor Development Block seeking four sets of informations. The BDO of Kaliabor Development Block sent a written statement dated 16<sup>th</sup> February, 2019, which is entered into the case records. It has been mentioned in the WS that the petitioner files large number of RTI petitions, but remains absent at the time of hearing his RTI first appeal petitions. The BDO also enclosed a copy of his letter dated 17<sup>th</sup> November, 2017 containing full addresses of the 10 GPS under the Block. Copy of that letter was given to the petitioner Shri Durgeswar Das also. It seems to have fully responded to the point no. 7 of the RTI petition dated 8.11.2017.

As regards the remaining 3 sets of informations sought for by the petitioner, it is seen that it is the concerned GPs who are holders of the sought for informations. The BDO, vide his letter dated 17<sup>th</sup> November had already transferred the RTI petition to the concerned GPs (10 nos) requesting them to furnish against point nos. 8, 9 and 10 of the RTI petition to the petitioner. On examination of those three points of the RTI petition it is seen that those are very simple informations, they can be furnished in one line each. The Secretaries of all the 10 GPS under Kaliabor Development Block are therefore, directed to furnish the informations to the petitioner against point nos. 8, 9, and 10 of the RTI petition within 15 days from the date of this order which was pronounced in presence all of them.

With the above order, the second appeal petition dated 19.2.2018 is disposed of.
