ORDER

13.03.2019

- 1. The petitioner Md. Anisur Rahman is absent without any information. This Commission's notice dated 26.2.2019 was also returned by the India Post authorities with the remark that attempts were made on 2nd March, 2019, 4th March, 2019 and 5th March, 2019 to deliver the notice but the door of the house, which was given as his address by the petitioner in his RTI petition, was found locked on all the three days and hence the notice was returned undelivered.
- 2. The public authority, i.e., the Environment & Forest Department is present as represented by Sri Amarendra Barua, IAS, Secretary & First Appellate Authority of Environment & Forest Department and Smti Smitakshi Baruah, ACS, Joint Secretary and SPIO of Environment & Forest Deptt. The second appeal petition dated 11.9.2017 is taken up for hearing ex parte in the absence of the petitioner.
- 3. From perusal of the RTI petition dated 5.11.2016, of which the instant second appeal petition dated 11.9.2017 is a sequel, it appears that the instant case is also related to the second appeal case no.SIC/KP(M).1158/2018 which was disposed of today with a final order. Hence this second appeal case also is clubbed together with the other two second appeal cases No.SIC/KP(M).1158/2018 and SIC/KP(M).1159/2018.
- 4. In the instant second appeal case the petitioner wanted the following informations :- (i) the reasons for marking copy of suspension order No. FRE.16/2001/Pt/80-A dated Dispur, 26th June, 2007 to Sri Ajit Singh, Parliamentary Secretary and local MLA of Udharband Constituency where the petitioner worked as Range Officer, (ii) Can Government mark copy of suspension order to unauthorized and unconcerned person? if so, to provide the petitioner copies of relevant provisions of FR &SR or Discipline and Appeal Rule, and (iii) the reasons for marking suspension letter only to satisfy Sri Ajit Singh who was then a political personality.
- (i) and (iii) above appear to be meaning the same thing and hence they are clubbed together.

- 5. In view of the aforesaid, it is ordered that the directions as contained in para 5 of this Commission's order dated 13.3.2019 in second appeal case No.SIC/KP(M).1158/2018 will apply mutatis mutandis in the instant second appeal case also.
- 7. With the above order, the second appeal petition dated 11.9.2017 is disposed of.
