O R D E R
02.05.2019

1. The second appeal petition dated 29.1.2018 read with RTI petition dated 21.11.2017, is taken up for consideration ex parte in the absence to the appellant.
2. It is seen from the case records that the petitioner filed an RTI petition dated 21.11.2017 before the SPIO of District Elementary Education Officer, District Darrang, Mangaldoi. Vide letter dated 15.12.2017 the DEEO, Darrang transferred the RTI petition to (i) Dy. Inspector of Schools, Mangaldoi, (ii) BEEO of Sipajhar (iii) BEEO of Kalaigaon and (iv) BEEO of Dalgaon. Two written submissions, both dated 29.4.2019, have been received from the Director of Elementary Education, Assam and i/c BEEO, Dalgaon, I/C BEEO, Kalasigaon also submitted a WS dated 30.4.2019. A copy of letter dated 29.4.2019 from DI of Schools, Mangaldoi addressed to the appellant Sri Mukul Choudhury has also been received. – They are entered into the case records.
3. In the RTI petition of Sri Mukul Choudhury enclosed a list of 50 Upper Primary School Teachers indicating the date of appointment against each teacher. He sought the following informations :-
 (i) The basis on which the teachers are working and receiving their salary, and
 (ii) the name of the school and the Educational Block in which they are working.
4. The informations furnished so far by the BEEO of Kalaigaon, Sipajhar and Dalgaon Education Blocks and DI of Schools, Mangaldoi appear to be incomplete.
5. With a view to furnishing complete information, the above four officials are directed to take the following actions within 20 days from the date of receipt of this order.
 i) From the list of 50 teachers provided by the appellant, identify the teachers who are being paid salary by the DI, Mangaldoi and the concerned BEEOs.

- ii) Make copies of the relevant documents like appointment order or transfer order, joining report and approval of Finance Department or higher Administrative Authority to pay salary to those teachers indicating the date from which salary has been paid and till when paid.
 - iii) Against each teacher, the name of the school where they are working at present be indicated.
 - iv) Communicate the above informations as at 5(i) to 5(iii) above to the petitioner within 20 days from the date of receipt of this order..
6. With the above order, the second appeal petition dated 29.1.2018 is disposed of.
