**O R D E R**  
20.5.2019

1. The gist of the case is that vide RTI petition dated 22.3.2019 the petitioner/appellant sought certain informations from the PIO of Dibrugarh Municipal Board. Not getting the required informations she filed first appeal petition dated 3.5.2018 before the FAA followed by second appeal petition dated 21.6.2018 before this Commission. In its order dated 28.1.2019, the informations which should meet the requirements of RTI petition dated 22.3.2018 was listed and accordingly it was directed that those informations be furnished to the petitioner within 15 days from the date of receipt of the order.

2. The petitioner/appellant vide her letter dated 15.3.2019 has reported that the SPIO of Dibrugarh Municipal Board has not provided any information to her even after above mentioned order of this Commission. **The SPIO of Dibrugarh Municipal Board is, therefore, directed to :-** (i) report compliance of this Commission's order dated 28.1.2019 within 15 days from the date of receipt of this order. (Enclose a copy of the order dated 28.1.2019 for his ready reference), and (ii) show cause within 15 days from the date of receipt of this order as to why any one or more of the penal action u/s 20 of the RTI Act, 2005, shall not be taken against him for his failure to comply with this Commission's order dated 28.1.2019 and also under relevant provisions of the RTI Act, 2005. If there is no designated SPIO appointed by the Dibrugarh Municipal Board, then the CEO of the Dibrugarh Municipal Board shall be deemed to be the SPIO in exercise of the powers conferred u/s 19 (8) (a) (ii) of the Act.

4. **Fix 12.30 PM on 24<sup>th</sup> July, 2019 for review of compliance.**

5. **Issue notices to both the parties accordingly for the attendance on the next date of hearing.**
