

1. The petitioner Shri Dulal Bora is absent. He has however, sent an e-mail dated 11th April, 2019 praying for re-fixation of the date of hearing on the ground that he is out of station to exercise his voting right for Kaliabor Lok Sabha constituency election today. 2. The Under Secretary and SPIO of Home Department, Shri Ramesh Medhi is present. He has submitted a written statement dated 6th April, 2019 stating that the instant second appeal petition dated 24.7.2017 read with the RTI petition dated 31.8.2016 is a repetition of an earlier RTI application vide D.No.DB.916/16 dated 9.8.2016, reply of which was already furnished to him vide department's letter dated 23.5.2017 followed by disposal of the corresponding second appeal case No. KP(M) 847/2017 vide order dated 23.7.2018.

3. From perusal of the case records and enclosed documents of WS submitted by the SPIO of Home Department it is found that the submission made in the WS is correct. The instant second appeal case is nothing but repetitive of the earlier second appeal case No. KP(M).847/2017.

4. The Registry of this Commission has also reported several such repetitive second appeal petitions filed by the instant appellant Shri Dulal Bora. He is, therefore, directed to take due care and precaution to avoid submission of such repetitive second appeal petitions or complaint petitions so that valuable time of this Commission as well as the public authority are not wasted.

With the above order, the second appeal petition dated 24.7.2017 is disposed of
