O R D E R

10.05.2019

1. The second appeal petition dated 4.12.2017 read with the RTI petition dated 23.1.2017 and first appeal petition dated 14.8.2017 are taken up for hearing in presence of both the parties.

2. The SPIO of Governor's Secretariat has submitted a written statement dated 10.5.2019, which is entered into the case records. It is mentioned in the WS that on 23.1.2017 the petitioner Sri Dulal Bora submitted 43 nos. of RTI petitions in one lot. It appears that these RTI petitions were with reference to separate complaint petitions filed by the same petitioner before the Governor's Secretariat. The SPIO mentioned in his letter dated 10.5.2019 that though in his RTI petitions numbering 43, the petitioner referred to 43 nos. of separate complaint petitions, as per records of Governor's Secretariat only 25 and not 43 nos, of complaint petitions were received. Subsequently, since the subject matter of the allegation letters were not related to the Governor's Secretariat, the same were sent to the office of the Chief Secretary, Govt. of Assam vide letter dated 29th July, 2016. The SPIO has also mentioned that the letters of allegations were related to different subjects falling under different departments of Govt. of Assam and that informations relating to these allegations are not held by the Governor's Secretariat. He also referred to an order No. CIC/SA/A/2016/001483 dated 1.8.2016 of the Central Information Commission which observed that *"the offices of President, Vice-President, Prime Minister, Governors, Lt. Governors and Chief Ministers are not legally obliged under RTI Act to entertain RTI application seeking information unrelated to it, or not held or controlled by these high offices"*. The SPIO of Governor's Secretariat informed the petitioner of the above position vide letter dated 18.2.2017. The petitioner orally acknowledged receipt of this letter.

3. In view of the above, the SPIO of Governor's Sectt. submitted orally that there was no option other than transferring the matter to the office of the Chief Secretary, Govt. of Assam, and that they did not furnish any further information to the information seeker.

4. From perusal of the case records it is seen that by his RTI petition dated 23.1.2017 the petitioner wanted to know the status of inquiry into the allegations that he made vide his complaint petition dated 12.9.2016 before the Hon'ble Governor of Assam. The complaint petition contained allegations against some officials of Transport Department. The petitioner

submitted orally that he has meanwhile received the sought for informations from the Transport Department. He submitted a written statement dated 10.5.2019 to that effect.

5. With the above, the second appeal petition dated 4.12.2017 is disposed of.
