1. The appellant Shri Dulal Bora sent an e-mail dated 6.5.2019 stating that due to his illness he is not able to attend today's hearing. He prayed for re-fixation of the date of hearing.

However, the SPIO and Under Secretary, Personnel Department submitted a 2. written statement dated 4.5.2019 with supporting documents. She stated in her WS that the same matter was already disposed of by this Commission vide an order dated 2.11.2018 in another second appeal case No. SIC/KP(M).334/2018. The Registry of this Commission placed case records of second appeal case No. SIC/.KP(M).334/2018 before this Commission. From perusal of the said case records it is seen that the petitioner filed an RTI petition dated 9.8.2016 followed by second appeal petition dated 24.7.2017 with reference to a complaint petition dated 12.8.2015 filed by the petitioner Shri Dulal Bora against the former Secretary, APSC Shri Trailokya Mohan Sarma before the Chief Secretary, Government of Assam. The RTI petition dated 31.8.2016, subsequent second appeal petition dated 24.7.2017 and the original complaint petition dated 12.8.2015 in the instant second appeal case are identical with the corresponding documents in the other second appeal case No. SIC/KP(M). 334/2018, which was already disposed of by this Commission vide order dated 2.11.2018. As noted in that order, the appellant Shri Dulal Bora submitted a written statement dated 2.11.2018 to the effect that he had received the informations to his satisfaction.

3. From the above, it is obvious that the instant second appeal case No. SIC/KP(M). 969/2018 is merely a duplication of the earlier second appeal case. The petitioner is directed once again to avoid such duplications in future as it amounts to wasteful expenditure of time and other valuable resources of the concerned public authority as well as of this Commission.

With the above order, the instant second appeal petition dated 24.7.2017 is disposed of.
