ORDER 15.05.2019

Ultimately, the information has been received and the same has been sent to the Appellant by Speed Post through a letter dated 10.05.2019. Considering that the information has been furnished by Speed Post to the Appellant, although belatedly, the Second Appeal is hereby disposed of. However, DDC, Nalbari is directed to abide by the provisions of the RTI Act, 2005 as regards furnishing of information within the time limit specified therein.
