**O R D E R**

15.05.2019

The Appellant, Sri Kamal Kumar Jain is present.

The SPIO absent.

Perused the case record. It is seen that a Written Statement dated 13.05.2019 has been received by e-mail from the SPIO, Nalbari Municipal Board along with statement of assessment of holdings as enclosures. It has been submitted that the information sought for through RTI Application dated 22.05.2018 has been furnished with acknowledgement by the Appellant on the margin of the Written Statement. It is however seen that in his acknowledgement he had recorded his objection that the assessment documents of holdings contained wrong information about the boundaries thereof. A copy of a letter written by the SPIO to Sri Dhiren Kr. Barman, Tax Daroga of the Nalbari Municipal Board dated 13.05.2019 has also been received in the Commission. Through this letter the SPIO had directed to Tax Daroga to be present in today's hearing.

It is evident that the said Tax Daroga did not attend the hearing.

The Appellant submitted that he had received the information only yesterday, 14.05.2019. He added that the so called "assessment of land holdings" on which he had sought information did not contain correct address in respect of the surroundings of the boundaries. On the Written Statement containing his acknowledgment he added in writing about his submission.

Considering the facts as brought out above, **the Commission hereby orders that the SPIO shall review and verify the statement of assessment of holding furnished to the Appellant with reference to his objection and furnish factual information with relevant documents duly certified, free of cost, within 15 days of receipt of this order.**

**The Second Appeal is hereby disposed of.**
